# **Privacy Policy**

NNN Properties, LLC ("NNN" or the "Company") values our customers and is committed to privacy and transparency on information we collect. Therefore, we want to inform you of our privacy policy setting forth how we handle the information you share with us and/or provide us online and/or through any written documentation submitted as part of a real estate transaction (or potential real estate transaction). The NNNPro.com website and any associated mobile applications (collectively, the "Site") is a service of NNN, a New York corporation. This privacy policy describes how we collect, use, protect, disclose and/or otherwise process the information, including personal information, that you provide. This policy also describes the rights our customers have with respect to managing such information, including opting out. Please read this Privacy Policy carefully. By accessing or using the Site and/or registering with the Site, you agree to this Privacy Policy.

You must be at least 18 years of age to use this Site. By continuing to use this Site, you represent and warrant that you meet the age eligibility requirement.

This policy is intended to provide our general practices and procedures, and in some cases, different or additional policies and notices about NNN's data collection and processing may be provided and apply to your personal information. Therefore, please review any applicable privacy policy when provided.

This Privacy Policy does not apply to employees or certain non-employees, including job candidates who apply for employment with NNN.

California Residents should be sure to review Section 11, "California Privacy Rights," for relevant information about the various categories of personal information NNN collects and discloses, as well as your rights under California privacy laws.

### 1. Collection of Personal Information

We collect information that you share with us through the use of our Site (including when you create an account with us), via communications with real estate brokers, and/or when you purchase or sell real estate with NNN (or inquire about a purchase or sale of real estate). We may also collect information about you through third-party sources, such as social media platforms, brokers, affiliated agents, and any other real estate professionals, brokers and agents, public databases, marketing databases, and other third parties.

**Personally Identifiable Information** collected may include, but is not limited to, customer's name, physical and email addresses, telephone, mobile and fax numbers, and real estate-related information, including any real estate, insurance, lending and title interests and needs.

We collect Personally Identifiable Information when you create an account, provide contact information or send other personal information to us. In addition, we collect such information when you submit information to us through any inquiry about our real estate

offerings or otherwise contact us. Furthermore, we may collect such information when you submit information to us in connection with a real estate search or during the purchase or sale of real estate. Finally, we may collect or receive Personally Identifiable Information from third parties such as brokers, affiliated agents, and any other real estate professionals, brokers and agents, public databases, social media platforms, and other third parties.

We may also collect **Non-Personally Identifiable Information**, which is information that does not personally identify you. Non-Personally Identifiable Information can include IP addresses, the type of browser and operating system being used, search terms used on our Site (or through any mobile application), domain name of your internet service provider, specific web pages you visit on our Site, the duration and frequency of your visits to our Site, location information and third-party websites from which your visit originated.

Such information may be collected through the use of our Site and related services, and in certain instances from third parties (payment processors, data providers, etc.). We will seek your consent or give you certain choices prior to collecting or using such personal information where required by law.

Please note, this Privacy Policy does not cover the collection of Personally Identifiable Information and/or Non-Personally Identifiable Information by other companies and other applications, and we are not responsible for their activities and how they handle the collection of such information.

#### 2. Purposes of Processing Personal Information

NNN collects, uses, discloses and otherwise processes personal information for various purposes depending on the circumstances. Pursuant to certain laws, NNN is required to inform you of the legal basis for processing personal information. Accordingly, we process personal information for the purposes set forth below:

- Personalizing customer experiences and content, including personalizing your experience on the Site and tailoring content on the Site. (Legal basis: in furtherance of our legitimate business interests)
- Providing our services to our customers and potential customers, including facilitating communications with brokers, affiliated agents, and any other real estate professionals, brokers and agents; communicating with customers and potential customers about accessing and using our Site and related services we offer; performing contracts; responding to customer or potential customer inquiries and requests for information (including regarding types of property offerings); notifying customers and potential customers of new services and product offerings of NNN; and other customer (or technical) support. (Legal basis: in furtherance of our legitimate business interests and performing pursuant to a contract)
- Evaluating and improving the usability and accessibility of our Site and any related services and business of NNN as well as maintaining and designing the Site. This includes understanding how our users access and use our Site, whether and how to

develop and improve our Site and related services and business offerings, other research and analytical purposes (such as reviewing traffic patterns and learning about the usage of the Site), and any other related legitimate business purposes. (Legal basis: in furtherance of our legitimate business interests)

- Providing marketing, advertising and other promotional information and materials (including but not limited to through emails, newsletters, and ad campaigns) that is relevant for our customers and potential customers, including evaluating and improving the effectiveness of such endeavors. (Legal basis: in furtherance of our legitimate business interests)
- Planning and addressing any actual or contemplated merger, acquisition, asset sale or transfer, reorganization, or other business transaction. (Legal basis: in furtherance of our legitimate business interests and/or compliance of law)
- Addressing internal operations, audits, and corporate governance matters. (Legal basis: in furtherance of our legitimate business interests and/or compliance of law)
- Responding to actual or potential legal matters and claims, including anticipated litigation, and/or defending or protecting NNN's rights or interests. (Legal basis: in furtherance of our legitimate business interests and/or compliance of law)
- Complying with legal process and obligations, including but not limited to court orders, subpoenas, warrants, and any regulatory or law enforcement demands and requests. (Legal basis: in furtherance of our legitimate business interests and/or compliance of law)

### 3. Sharing and Disclosure of Information Collected

NNN may have business purposes for disclosing your personal information to third-party service providers ("Service Providers"), but only as reasonably necessary for the abovementioned purposes and to the extent directed or otherwise authorized by you. Disclosures of your voluntarily shared Personally Identifiable Information to our Service Providers will be primarily to connect you with brokers, affiliated agents, and any other real estate professionals, brokers and agents; to inform you about NNN's products, services and other real estate offerings; to conduct and coordinate marketing and promotions; to maintain updated customer information; to analyze and store data; or to otherwise provide services in the sale or purchase of real estate. In addition, NNN may disclose Non-Personally Identifiable Information to assist in analyzing traffic and trends in usage, implementing targeted promotional activities, and improving NNN offerings and services. The Service Providers are provided with only the information necessary to perform the requested services, and NNN only authorizes such providers to use this information to carry out NNN's requests. In addition, please note that NNN reserves the right to disclose your personal information under limited circumstances as required by law or legal process, including to cooperate with law enforcement or judicial authorities, to protect NNN's legal rights, or protect the public. Please see Section 7, Rights and Choices including "Opt-Out," for opt-out options.

NNN will not sell your personal information or otherwise use such information in any manner outside of the scope of this Privacy Policy without your prior approval.

NNN utilizes commercially reasonable security procedures and practices to safeguard your privacy. However, we cannot guarantee the security of any information you provide, and NNN accepts no responsibility or liability for the activities of third parties. Please see our Terms of Use for further information.

# 4. Cookies, Tracking Technologies, and Analytics

As is common practice, when you visit our Site (or any mobile application), NNN may collect information through the use of cookies (first and third parties), plug-ins, web beacons, and other tracking technologies (e.g., small files placed on your computer by consumer applications). Such cookies collect information on usage of websites, time on the Site, pages visited on the Site, any language preferences, and other anonymous traffic data. ### 6. Data Retention

NNN will retain personal information for the period necessary to fulfill the purposes outlined in its Privacy Policy unless a longer retention time period is required or permitted by law. For instance, when required by our legal and regulatory obligations, professional indemnity obligations, or when NNN believes it is necessary to establish, defend, or protect its legal rights and interests (or those of others), NNN may retain personal information for longer. With regard to data and files we handle as a processor, NNN retains this personal information in accordance with customers' instructions.

### 7. Rights and Choices Including "Opt-Out"

We are committed to respecting the privacy rights of our Site users under all privacy laws applicable to NNN. As such, you have several ways to exercise certain privacy choices regarding any personal information processed by NNN.

The request will be processed in accordance with any applicable law. NNN will need to verify your identity before implementing and processing such request, which can include linking any personally identifiable information with the linked email address. The request will be processed based on the personal information in our records that is linked or reasonably linkable to the information provided in your request. In certain circumstances, we may request additional information to verify and/or process your request. In certain circumstances, we may not be able to process your request, and you will be notified. We can process authorized agent requests upon proper authorization of the agent and possibly the underlying requestor. In addition, certain information may need to be maintained for recordkeeping purposes, to complete a transaction, to be maintained as non-removeable residual information in our records, or for any other lawful purposes. This request may take some time, but NNN will endeavor to process such as soon as reasonably practicable.

Please note, if you activated an account with NNN, you can deactivate it at any time by utilizing the deactivation feature in the account services or by contacting us as indicated above. This request may take some time, but NNN will endeavor to process such as soon as reasonably practicable.

### 8. Children

Our Site (and any mobile applications) and our other services, products and technology solutions (collectively, the "Services") are not intended for or directed to children under the

age of 18, and NNN does not knowingly collect any personal information or knowingly track the use of our Services by children. If NNN has actual knowledge that personal information regarding any child under the age of 18 has been collected, then NNN will take appropriate steps to try to delete such personal information.

# 9. Third-Party Websites

NNN's Services may contain links to third-party services. NNN does not own, operate or control the websites of third parties. We are not responsible for the privacy practices of other services, and we expressly disclaim any liability for their actions, including related to the use and disclosure of personal information by such third parties.

# 10. Changes to Privacy Policy

NNN may disclose any of the above categories of personal information collected from you to other third parties as consented and/or directed by you, or where necessary to complete any of your specific requests to NNN.

#### Sale and Sharing.

The CCPA defines a "sale" as making or disclosing personal information to a third party in exchange for monetary or other valuable consideration, and "sharing" broadly includes disclosing or making available personal information to a third party for purposes of cross-context behavioral advertising. While we do not disclose personal information to third parties in exchange for monetary compensation, NNN may "sell" or "share," as defined by the CCPA: (i) identifiers, usage data, customer records, commercial information and profiles with NNN's affiliates, for purposes including, but not limited to, improving their records, and (ii) identifiers, usage data and commercial information to social media platforms, data analytics providers and ad networks, for purposes including, but not limited to, improving our marketing and ad campaigns.

#### Retention.

NNN will retain your personal information for the period of time necessary to fulfill the purposes addressed in this Privacy Policy or as otherwise disclosed to you at the time of the collection, unless a longer period of time for retention is necessary, including as permitted and/or required by law.

#### Rights of California Residents.

California residents, in general, have the following rights under the CCPA:

With respect to any personal information collected and maintained by NNN:

- **Non-Discrimination**. No discriminatory treatment for exercising any rights under the CCPA.
- **Correction**. Ability to request correction of inaccurate personal information.
- **Deletion**. Ability to request the deletion of personal information, subject to certain exceptions.
- **Opt-out -Sales and sharing**. Ability to opt out of NNN's sale and sharing of personal information.
- To Know and Access. Ability to know what personal information is collected by NNN

   categories of personal information, sources from which such information is collected, business and commercial purpose for the collection, sale, and/or sharing of such information, third parties to whom personal information is disclosed, and specific personal information collected.

• Limits on Use and Disclosure-Sensitive Personal Information. Ability to limit NNN's use or disclosure of sensitive personal information to only those authorized users under the CCPA.

#### CCPA Requests.

The request will be processed in accordance with any applicable law. NNN will need to verify your identity before implementing and processing such request, which can include linking any Personally Identifiable Information with the linked email address and/or matching the information you provide with the information we have in NNN's records. The request will be processed based on the personal information in our records that is linked or reasonably linkable to the information provided in your request. In certain circumstances, we may request additional information to verify and/or process your request. In certain circumstances, we may not be able to process your request, and you will be notified. We can process authorized agent requests upon proper authorization by the agent and possibly the underlying requestor. In addition, certain information may need to be maintained for recordkeeping purposes, to complete a transaction, or be maintained as residual information in our records, which is non-removeable, or for any other lawful purposes. We will respond to all CCPA requests within 90 days of receipt. We endeavor to respond to all CCPA requests within 45 days of receipt and will notify you if we are unable to do so.

### Rights under California Shine the Light Law.

California residents may also request from businesses with whom they have an established business relationship the following information:

- A list of categories of personal information name, address, email address, and types of services provided to the customer – that a business has disclosed to third parties during the immediately preceding calendar year for the third parties' direct marketing purposes, and
- Names and addresses of all such third parties.

Any requests for such information should be directed to the contact information above. Such requests will be responded to within thirty (30) days.

### Right to Change Our Privacy Policy.

NNN reserves the right to amend its Privacy Policy at its discretion at any time. We will post an updated policy on this Site. Any continued use of our Site or Services following the posting of the updated policy constitutes your acceptance of such changes.

### 12. Privacy Rights of Other US States

Residents of certain US states, including Virginia, Connecticut, Colorado, and Utah, may have additional rights under applicable privacy laws, subject to certain limitations. Such rights may include:

- **Deletion**. The option to delete personal information provided to or obtained by NNN.
- **Opt-Out**. The ability to opt out of certain types of processing, such as (a) "sale" of personal information, (b) targeted advertising, and (c) processing of personal information for purposes of making decisions that produce legal or similarly significant effects (if applicable).
- **Correction**. The ability to correct any inaccuracies in a customer's personal information.
- Access. The ability to confirm whether NNN is processing personal information and obtain a copy of such personal information (which will be portable and in a readily usable format, to the extent technically feasible).
